

**PEACE RIVER REGIONAL DISTRICT
Bylaw No. 2053, 2013**

A bylaw to impose fees for the disposal of solid waste
at Regional District Solid Waste facilities

WHEREAS the Regional Board of the Peace River Regional District did, pursuant to the Province of B.C. *Local Government Act*, R.S.B.C. 1996, c. 323 adopt the "Solid Waste Regulation Bylaw No. 2005, 2012";

NOW THEREFORE the Regional Board of the Peace River Regional District, in open meeting assembled, hereby enacts as follows:


1. This bylaw may be cited for all purposes as "Solid Waste Disposal Fee Bylaw No. 2053, 2013."
2. Every person disposing of Solid Waste at a transfer station, or a landfill site shall pay the Applicable fees and other charges to the Regional District.
3. The fees and other charges applicable in relation to the disposal of Solid Waste at a Landfill Site or a Transfer Station, shall be as set out in Schedule 'A', 'B' and 'C', attached to and forming part of this bylaw.
4. Where fees are collected, in the event that there are no scales provided at a Landfill Site or Transfer Station or the scales provided are not operational, the fees shall be as set out in Schedule 'B'.
5. Capitalized items in this bylaw have the meaning attributed to them in Section 2 of "Solid Waste Regulation Bylaw No. 2005, 2012."
6. "Solid Waste Disposal Fee Bylaw No. 2044, 2012" is hereby repealed.

READ a THIRD TIME this 28th day of February, 2013.


