**MP ZIMMER, PRINCE GEORGE – PEACE RIVER – NORTHERN ROCKIES –
ISSUES AFFECTING THE REGIONAL DISTRICT**

MP Bob Zimmer, Prince George – Peace River – Northern Rockies, provided the Board with an update on the wildfires affecting Williams Lake and area. After providing information on his various governmental roles an open discussion with the Regional Board was held. Discussions included:

- CN Rail. Board concerns included rail line access and upgrades in Tumbler Ridge, effects of the 2016 flood event on CN culverts, rail line maintenance including vegetation management, the Pouce Coupe trestle, private crossings, and fencing. MP Zimmer offered to assist the Board in arranging a meeting with CN.
- HD Mining International Ltd. – Murray River Project. The Board shared concerns regarding environmental approvals and permitting. MP Zimmer requested that Director McPherson, District of Tumbler Ridge, forward further information to him.
- GottaGo Report. The Board provided an overview of the report and the positive effects its recommendations would have on economic development, tourism, and driver safety. MP Zimmer suggested that access for persons with disabilities be included in the initiative.
- Drive BC. The Board shared its wish to have the route from Mile 83 of the Alaska Highway to the Yukon border included in the Drive BC travel advisory program.
- Canada Post mailboxes. The Board shared resident concerns regarding the theft, vandalism and personal maintenance of older green mailboxes. MP Zimmer offered to write a letter of support for the request for new mailboxes.
- Liquid Natural Gas (LNG). The cancellation of the Pacific NorthWest LNG project was discussed.
- North Peace Horticulture Study. The Board discussed the positive effects of the proposed project and requested MP Zimmer's support following approval.
- North American Free Trade Agreement (NAFTA). MP Zimmer shared information regarding his attendance at Washington, DC to discuss softwood lumber.

MP Zimmer agreed to meet with Board Directors, either individually or collectively, to discuss initiatives such as the GottaGo Report further.
