12) R-3 contaminated sites

BC's Ministry of Environment (MoE) is reviewing aspects of its site remediation legal regime, specifically the mechanisms listed in the following intention papers and is looking for comments from local governments on the Identification of Contaminated Sites and the Prevention of Site Contamination from Soil Relocation, deadline for comments to both papers is August 31, 2016. Historically local governments were able to opt out of this process, under the proposed process this is no longer the case.

A preliminary review has identified the following:

- Application for a building permit, applicant will need to provide a letter/report from a qualified professional verifying remediation. Documents need to be kept on file. How will this occur in areas where there is no building inspection area? Will the Building Inspector need additional training/expertise, are they qualified? Will there be more costs incurred by the Regional District for additional work.
- Invasive plants are not addressed in the intention papers, i.e. gravel being removed from gravel pits that are infested with weeds. The Ministry wants it exempted.
- Applications for Certificate of Restoration will no longer be a trigger, however the site must be identified during decommissioning who assumes responsibility, the landowner?

It was noted that staff will compile a comprehensive list of concerns and identified issues which will be forwarded to the Solid Waste Committee for their review and input (via email) with a deadline for comments of August 18. A final report will be on the August 25th Board agenda, which will allow time for additional comments prior to submission to the Ministry by August 31.

- a) that the Solid Waste Committee recommends to the Regional Board that staff be authorized to collate and provide comments, prior to August 31, 2016, to the BC Ministry of Environment with respect to the intentions papers, "Identification of Contaminated Sites" and "Prevention of Site Contamination from Soil Relocation"; and
- b) that the comments be reviewed by the Regional Board at its meeting on August 25 for approval prior to being forwarded to the BC Ministry of Environment.
