

# PEACE RIVER REGIONAL DISTRICT

## Bylaw No. 2120, 2014

A bylaw to convert the authority for providing an invasive plant control service within the Peace River Regional District

WHEREAS pursuant to supplementary letters patent the Peace River Regional District has been granted authority to provide the service of controlling noxious weeds and other growths, with all member municipalities and electoral areas participating;

AND WHEREAS the aforesaid function of noxious weed control has been provided as a continued service of the Peace River Regional District in accordance with the previous continuation authority as defined in the *Local Government Act*;

AND WHEREAS the Regional District Board wishes to convert the noxious weeds service to a service exercised under the authority of an establishing bylaw and to amend the provisions thereof in accordance with section 774.2 of the *Local Government Act*;

AND WHEREAS the written consent of at least 2/3 of the participants of the service has been obtained pursuant to section 802 of the *Local Government Act*;

NOW THEREFORE the Regional Board of the Peace River Regional District, in open meeting assembled, enacts as follows:

1. SERVICE CONVERTED

The noxious weeds service established by Division XIX of supplementary letters patent issued March 31, 1976 is hereby converted to the Invasive Plant Control Service to be exercised under the authority of an establishing bylaw in accordance with the provisions of this bylaw;

2. BOUNDARIES

The boundaries of the Service Area are coterminous with the boundaries of the Peace River Regional District.

4. PARTICIPATING AREAS

The participating areas are all the electoral areas and member municipalities of the Peace River Regional District.

5. COST RECOVERY

As provided in section 803 of the *Local Government Act*, the annual cost of providing the Service shall be recovered by one or more of the following:

- (a) property value taxes imposed in accordance with Division 4.3 of Part 24 of the *Local Government Act*;

- (b) parcel taxes imposed in accordance with Division 4.3 of Part 24 of the *Local Government Act*;
- (c) fees and charges imposed under section 363 of the *Local Government Act*;
- (d) revenue raised by other means authorized by the *Local Government Act* or another Act.

6. MAXIMUM REQUISITION LIMIT

In accordance with section 800.1(1)(e) of the *Local Government Act*, the maximum amount that may be requisitioned for the service is \$0.06/\$1,000 when applied to the net taxable value of land and improvements in the service area.

7. CITATION

This bylaw may be cited for all purposes as "Invasive Plant Control Service Establishment Conversion Bylaw No. 2120, 2014".
