

**PEACE RIVER REGIONAL DISTRICT**

**Bylaw No. 2427, 2021**

A bylaw to amend Peace River Regional District  
Zoning Bylaw No. 1000, 1996.”

WHEREAS, the Regional Board of the Peace River Regional District did, pursuant to the Province of British Columbia *Local Government Act*, adopt “Peace River Regional District Zoning Bylaw No. 1000, 1996”;

NOW THEREFORE the Regional Board of the Peace River Regional District, in open meeting assembled, enacts as follows:

- 1. This bylaw may be cited for all purposes as “Peace River Regional District Zoning Amendment Bylaw No. 2427, 2021.”
- 2. Index Map – Map 1 of “Peace River Regional District Zoning Bylaw No. 1000, 1996” is hereby amended in the following manner:
  - a) By adding the following permitted use to Part VI Zones, Section 36 A-2 (Large Agricultural Holdings Zone), 2. Regulations – Additional Uses:
    - (e) the following additional use is permitted on land legally described as:
      - Northeast ¼ of District Lot 41, Peace River District
      - (i) 500 person work camp and card lock fuel sales on a 10.7 ha (26.4 acre) portion of the subject property
