

**PEACE RIVER REGIONAL DISTRICT
Bylaw No. 2093, 2013**

A bylaw to amend the "Peace River Regional
District Zoning Bylaw No. 1343, 2001."

WHEREAS, the Regional Board of the Peace River Regional District did, pursuant to the Province of British Columbia *Local Government Act*, adopt the "Peace River Regional District Zoning Bylaw No. 1343, 2001";

AND WHEREAS an application has been made to amend the "Peace River Regional District Zoning Bylaw No. 1343, 2001" to facilitate a rezoning;

NOW THEREFORE the Regional Board of the Peace River Regional District, in open meeting assembled, enacts as follows:

1. This bylaw may be cited for all purposes as the "Peace River Regional District Amendment Zoning Bylaw No. 2093 (Mayer), 2013."
2. The "Peace River Regional District Zoning Bylaw No. 1343, 2001" is hereby amended in the following manner:

Schedule 'B' Map No. 9 is hereby amended by rezoning a portion of the Remainder of Southeast ¼ Section 17, Township 78, Range 15, W6M, PRD except Plans BCP18650 and BCP39424 from "A-2 (Large Agricultural Holdings Zone)" to "I-1 Light Industrial" as shown shaded on Schedule "A" which is attached to and forms part of this bylaw.

READ a FIRST TIME this 10th day of October, 2013.

READ a SECOND TIME this 10th day of October, 2013.

Public Notification published on the 30 day of March, 2017 and mailed on the 29 day of March, 2017.

READ a THIRD TIME this 13 day of April, 2017.
