## NOVEMBER 7<sup>th</sup> Referendum Results

The Board received the final results of the two referendums held on November 7<sup>th</sup>, 2015.

### DOMESTIC SEWAGE RECEIVING FACILITY BYLAW 2217

Final results confirmed that the referendum failed  
Ballots cast: NO-510 YES- 420  
Voter turnout: 12%

### POTABLE WATER SERVICE BYLAW 2212

Final results confirmed the referendum failed.  
Ballots cast: NO-763 YES- 701  
Voter turnout: 13%

## 2016 Budget planning

The BC Rural Network aims to build stronger rural and remote communities in BC by promoting better understanding of rural issues across all jurisdictions, and developing responses to rural issues.

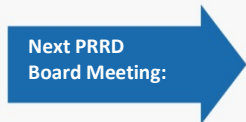
## Scentsless Camomile
