# Fiber is the Future

# **Macro Market Drivers**

- Cloud computing and Software as a Service in the commercial and enterprise sectors, together with streaming media and online gaming in the residential market, have created a steadily increasing demand for higher bandwidth speeds
- Copper and wireless technologies cannot supply the bandwidth speeds and quality of service that the market is demanding
- A rollout of Fiber to the Premise (FTTP) to both commercial and residential locations will take place over the next 5 years
- Incumbent Telco's cannot access and support sufficient capital to address the entire market





## Hi Crystal

I am currently out of the country and will be returning in mid January. I have a sporadic access to email, so I thought I would take advantage of it at the moment to pass on both some of our experiences with "broadband" development, and some issues that both could and should be addressed by a regional district government that has identified connectivity as an issue.

First lets take on the definition of "broadband itself". As a term it is a meaningless catchall for network connectivity that has no specific qualitative value and can be manipulated to fit the circumstances. In fact various sectors of government are adjusting the baseline of "broadband" on a continuing basis. For example;

The CRTC and ISED currently define it as a service connection with a download capacity of 30 Mbps and an upload capacity of 10 Mbps. This is meaningful only in the context of providing a baseline that a provider needs to be able deliver in order to be seen as providing "broadband", and simply ignores any and all issues of what can or cannot be achieved with it.

Probably the single most significant exercise that PRRD or any other rural government entity can do is to conduct a needs evaluation as to what is required to support the economic base and quality of life needs and expectations of the communities in the region.

This process is always a challenge as rural areas are unlikely to have skilled local people in the community with the experience to carry this out, and depending on the telecom monopolies to provide this insight is seldom done to the advantage of any community.

Kaslo infoNet was founded and has grown as a community not for profit society that was the community effort to provide for itself what for profit telecom companies were unwilling to provide.

This is in fact how KiN came to be in the first place. In Kaslo in the mid nineties connectivity was by dial up modem. Access to the modem banks was a local call in many areas, but many rural exchanges didn't have modem banks and the dial up access call was toll charged as "long distance". KiN was originally incorporated in 1996 to provide a modem bank connection to provide un tolled dial up modem access for areas that were unfairly being toll charged for access. In fact those services lasted far longer than expected. In the late nineties DSL services arrived in the cities, but rural areas did without. This led KiN to build wireless radio networks to serve the areas that were beyond reach of DSL.

Telcos would provide DSL services "where it was profitable" and all others could do without. This led the BC governments of the day to push the telcos to provide internet connection ports to communities that they were not willing to serve so they could serve themselves. This was the Connecting Communities Agreement connection that made KiN wireless services possible in RDCK Area D.

In 2012 the Columbia Basin Trust set up a backbone network service that would provide higher capacity to communities that would build local "last mile" networks.

This effort was the trigger that convinced the Kaslo community KiN group to build local fibre to the premises networks. Why Kaslo? Kaslo had a few key individuals with contracting, permitting, fibre and network management expertise, and the KiN NFP wireless ISP society already in place with a dozen

years of operational experience.

KiN from 2006 to 2012 served a little over 250 users at 1.5 to 3.0 Mbps all on wireless services from "CCA" ports

KiN in 2019 serves around 200 wireless users, and over 500 fibre users, and provides land line telephone services at roughly half the costs of the telcos. The backbone is connected to Columbia Basin Broadband. This rate chart is the offering for 2020.

All telecommunications services are funded from the bottom up. It is the subscribers paying monthly connection fees at the "end point connection" that carry the costs of the network, and those revenues are always maximised as far as possible to contribute to the bottom line of the for profit telco.

When the revenue vs costs expectation is established in a dense city environment, it is small wonder that rural areas are largely ignored as "unprofitable".

What we have done in the Village of Kaslo, and Area D of the Regional District of Central Kootenay is simply to make our own optical fibre service network, and to provide not only internet access, but site to site LAN interconnections, telephone services, and data storage services.

This service operates with "fibre end points" capable of 1 Gbps on backbone fibres currently operated at 10 Gbps. This allows us to provide services to any end point that meet whatever requirements are today with a path for expansion for the future.

We have just completed a backbone fibre deployment that serves all of the communities in the north arm of Kootenay Lake from Balfour to Lardeau and Argenta, and we expect to see our endpoint count reach the 1000 mark over the next year or so with the bulk of our wireless service endpoints upgraded to fibre.

This society employs 5 full time year round employees and a seasonal construction crew of 5 to 10 more depending on projects. It operates in positive cashflow and has done so for more than 20 years

This sort of fibre technology is both affordable and manageable by rural communities, and future proof from the standpoint of speed and capacity. We are more than willing to share what we know and how to deploy it for the benefit of all rural communities.

I would also add that we will be involved with the BC Broadband Association's efforts to establish a Fibre Subcommittee to promote local fibre construction schemes in 2020.

**Subject: Bylaw Enforcement Update** 

## **RECOMMENDATION:** [Corporate Unweighted]

That the Electoral Area Directors Committee receive the report 'Bylaw Enforcement Update', dated December 31, 2019 for discussion.

# **BACKGROUND/RATIONALE:**

This report covers the period from January 1, 2019 to December 31, 2019. There are a total of 26 open bylaw enforcement files (18 Active and 8 Inactive). 38 files were closed in 2019.

There are 4 files on properties within the Old Fort Community. Three were placed on hold after the September 30, 2018 landslide. The other one was already on hold pending a Board of Variance application. Development Services is seeking direction as to when enforcement should resume on the 3 files placed on hold due to the landslide.

# Active Files (shaded blue):

There are 18 active enforcement files.

- 9 of these files are new since the last bylaw enforcement update on January 17, 2019.
- 1 of these files has been forwarded to PRRD legal counsel and a petition has been filed in BC Supreme Court

# Inactive or "On Hold" Files (shaded green):

There are 8 inactive or "on hold" files.

- File 11-194- At the June 14, 2018 Regional Board meeting, the TUP was approved pending receipt of confirmation of an ALC security and reclamation plan. We have confirmation that the security has been paid. The applicant is working with the ALC to provide the reclamation plan. The reclamation plan required by the ALC was for the gravel extraction area, not the work camp. The ALC has not been able to confirm if the reclamation plan submitted by the landowner is sufficient.
- File 16-111- applied to the Board of Variance on December 15, 2016.
- File 16-097- the Planning Department has received rezoning and development variance permit applications.
- File 15-103- Received 3<sup>rd</sup> reading for rezoning at the May 24<sup>th</sup>, 2018 Regional Board meeting, with final consideration pending the driveway re-location and a restrictive covenant being registered on title re: landscaping. A site inspection on October 24, 2019 found the property to be mostly clear of storage. This file was placed on hold due to the September 30, 2018 landslide that affected the Old Fort Community. This property is currently within an Evacuation Alert Area.
