REPORTS:

D-1 and R-1 April 3, 2019 - Fire Protection Service Review Electoral Area C and Electoral Area D South to Kiskatinaw River Feasibility Study Report Discussion points included:

- Fire departments provide more than just "fire protection services"
- Other jurisdictions have shared / collaborative services that work well
- Single Mutual Aid would be preferred system
- Facilitate a coordinated approach, Regional District controls it
- Develop a strategic plan, to be self-sufficient for entire region (personnel and equipment).
- Service costs and potential insurance savings for property owners, taxation
- How many property owners would be interested in expanded service

MOVED by Director Sperling, SECONDED by Director Hiebert,

That the Electoral Area Directors Committee recommend to the Regional Board that a report be brought back to the Electoral Area Directors Committee outlining the associated costs for property owners within the proposed service area should an expansion of the Charlie Lake Fire Protection Area be approved, for the addition of two new satellite fire halls located in the Baldonnel and Lebel areas, to be operated as a single authority by the Regional District as part of the Charlie Lake Volunteer Fire Department.

R-2 April 3, 2019 – Expansion of the Charlie Lake Fire Department

Directors reviewed a map indicating the areas that could be included in the Charlie Lake Fire Protection area using the existing infrastructure, equipment and personnel. Staff have been researching possible alternative water sources.

It was suggested that staff develop an information package, including a survey, to determine if residents would be interested in being included into the fire protection area, and bring results back to the Committee. Service area boundaries could be amended if there is sufficient interest. It was noted that other services are provided besides fire - expansion of area, medical first responder, road rescue. Current establishment bylaw refers to "fire" only, would have to adopt a new establishment bylaw for provision of medical and road rescue services.

That the Electoral Area Directors Committee recommend to the Regional Board that a meeting be held with the owners of properties located in the Highway 29 North – under 13 Km, Sawyer Road, Wolsey Sub, Old Hope Road to determine their interest in being included into the Charlie Lake Fire Protection Service

Area, and further, the Old Fort be included in this meeting.

That the Electoral Area Directors Committee recommend to the Regional Board that an information package be developed and presented to the Electoral Area Directors Committee at its May 23, 2019 meeting; further, that the package include information for residents outside the current fire protection area about the option to expand the Charlie Lake Fire Protection area to the north and west, taxation cost estimates for the service, and requesting feedback from residents about their level of interest in receiving fire protection, road rescue and medical first response services.
