Northern Health - Public Water Tank Loaders

Crystal Brown, and Allan Torng both of Northern Health, attended the meeting to explain the recent notifications given for various public water tank loader sites within the Peace River Regional District. Due to the recent Groundwater Under the Direct Influence of Surface Water (GUDI) and Guidance Document for Determining Ground Water at Risk of Containing Pathogens (GARP) assessments of the Blackfoot, Boundary Lake, Prespatou and Fey Spring water systems, Northern Health determined that the water supplied is at risk to the public. As a result, the agency presented action plans for Blackfoot, Boundary Lake and Fey Spring that include:

- issue a boil water notice to all users;
- remove all "untreated water, use at your own risk" and "agriculture use" signs; and
- install appropriate signs indicating the potential of risks to users.

The action plan for Prespatou includes:

- remove all "untreated water, use at your own risk" and "agriculture use" signs;
- install a pressure tank large enough to accommodate the filling of a couple potable water containers;
- provide disinfectant for users to disinfect the end of the hose prior to filling;
- adjust the tap to keep it from touching the ground and ensure an air gap is present to prevent back flow contamination;
- obtain a Well ID plate from the Ministry of Environment and secure it to the well; and
- submit water chemistry data that is not older than three years.

Northern Health is willing to assist the Regional District to achieve the required changes and to education the public regarding the concerns and remedies for each water system.
