



Attending a Board or Committee Meeting

Description:

Peace River Regional District Board and Committee Meetings continue to take place at the Dawson Creek office following new procedures that include: Plexiglas partitions between Directors, social distancing and sanitization measures, conference calls, and livestreaming over Facebook live (Board Meetings only) video with closed captioning capabilities.

These new measures have allowed PRRD Board Members and members of the public to stay safe while continuing to maintain PRRD operations — keeping transparency and integrity in decision making.



Procedures for Attending a Board or Committee Meeting:

1 Board and committee meetings are currently being held in the Dawson Creek office, which has a maximum room occupancy of 26 people, including Directors and staff. As of June 1st, meetings are open to the public; however, only 4 additional members of the public are permitted at a time.



2 All those who enter the office are required to wash or sanitize their hands. If you wish to attend a meeting for a specific agenda item, please email prrd.dc@prrd.bc.ca to request a spot. Members of the public may be asked to wait in the reception area or outside of the building should the seating reach maximum capacity. All those who enter the office are required to sign in with Reception, as per COVID-19 requirements.



3 Board Meetings will continue to be livestreamed over Facebook, with closed captioning capabilities, on the Peace River Regional District [Official Page](#). To follow social distancing requirements, **please continue to watch Board Meetings online whenever possible.**

Requests and comments will be processed and approved on a first come, first serve basis. Written comments/questions will be read aloud during the Gallery Comments and Questions segment on behalf of the commenter.



Please note that Gallery Comments will not be authorized if the subject matter is of a commercial or for profit nature, or regarding a land use proposal or land use decision that has not yet been considered by the Board or that has been considered by the Board, and a public hearing, consultation, or information session specified.
