## Regional Hospital District Capital Budget

The Peace River Regional Hospital District 2015 Annual Budget Bylaw was adopted.

## PRRD Budget

The Board approved the Regional District's Five Year Financial Plan. The Plan includes the 2015 Budget for each of the Regional District's 54 functions.



## Regional Hospital District Board

The Board approved \$100,000 for a physician and nurse practitioner position targeted recruiter for PRRD communities.

Targeted recruitment is a relatively new initiative for Northern Health however they have learned that it can be very effective in communities that are facing recruitment challenges.

## Charlie Lake Sewer Upgrade Contract Award

The Regional Board awarded a contract to Graham Infrastructure LP for \$4,983,800 excluding taxes, for the upgrade of the Charlie Lake treatment plant and the construction of a sewer truck waste receiving facility.

## Changes to the notification area for development variance permit applications

Public notification for development permit notices has been amended to 100 meters. Public notification areas that overlap into a municipality will be a maximum of 100 meters for all land use applications.
