PRRD Office in Fort St. John

The satellite office in Fort St. John is closed due to smoke damage from a fire in the adjoining building. The extent of the damage is being assessed. Staff are working out of the Dawson Creek office.

Tomslake Natural Gas Extension

The Regional Board approved entering into a Pipeline Construction Tri-party agreement with Pacific Northern Gas (N.E.) Ltd. (PNG) and Encana Corporation (Encana), for the purpose of extending natural gas service to select properties in the Tomslake area. There is no financial obligation of the Regional District other than staff time to administer the project and legal fees which are expected to be minimal.

North Central Local Government Association Meeting Highlights

CN rail now has a program for communities to access to know what hazardous materials are being transported through their towns called AskRail.

The "Connecting BC" program will be administered by Northern Development Initiative Trust and will help to pay for infrastructure required to deliver high speed internet.

OCP and Zoning amendment

The Board deferred the Snider application to amend the OCP and zoning bylaw to enable light industrial uses for the purpose of selling the subject property until such time as the review of the North Peace Fringe Area Official Community Plan is complete.

Peace Region Electricity Supply (PRES) Project

Charles Young, Project Manager and Leslie Wood, Stakeholder Engagement Lead updated the Board about the project. The purpose of the project is to meet the anticipated increased electricity demand in the Dawson/Groundbirch area. Growth is due to the boom in unconventional gas production, and companies wishing to power their facilities from the BC Hydro grid. The Dawson Creek/Chetwynd Area Transmission (DCAT) project (under construction) will double capacity in the area. BC Hydro is still evaluating PRES Project route alternatives and expects to identify the leading alternative in the Fall this year.
