Agricultural Land Commission Applications (ALC)

The Board approved the Klassen, Anderson, Vause and Dakota Contracting Ltd. applications to proceed to the ALC.

Dunlevy Campground

BC Parks will be invited to a Parks Committee meeting to provide an update on future plans for the Dunlevy Campground on Williston Lake.

OCP Amendment Bylaw No. 2228, 2015 & Zoning Amendment Bylaw No. 2238, 2016 (Encana Corporation)

Another Public Hearing will be held at a future Board meeting to receive and consider additional information including: Wildlife Assessment Report, OGC/ALC approval for non-farm use in the ALR, and OGC Facility Permit #9709625. Encana will be requested to provide mitigation options for concerns raised about traffic increases and safety for school buses.

Charlie Lake Fire Department

Funds were re-allocated for roof repairs at the Charlie Lake Fire Department.

North Peace Airport Society

A letter will be forwarded to the North Peace Airport Society in support of its funding application to Northern Development Initiative Trust for a grant in the amount of \$25,865 to assist with the installation of LED lights in the North Peace Regional Airport parking lot.

Minaker River Park

The Parks Committee and Regional Board members will conduct a site visit at the Minaker River Park to determine the feasibility of repairing the driveway and reinforcing the river bed due to erosion problems.

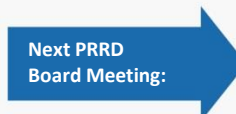


The June 23rd Regional Board Outreach Meeting will be held at the Taylor Community Hall.
