## **Tumbler Ridge Museum Foundation Update**

## **OCP and Zoning Amendment Bylaws**

The GSD Holdco Ltd OCP and Zoning amendment Bylaws to amend the OCP from MDR (Medium Density Residential) to LSI (Light/Service Industrial) and to amend the zoning from R-3 (Residential 3 Zone) to I-1 (Light Industrial) to allow for the development of the subject property as Light Industrial was adopted by the Board.

# **River Regional District Water Tank Loaders**

The Peace River Regional District (PRRD) is reminding people that the water tank loaders located at Blackfoot Park, Fey Spring and Boundary Lake are not a potable water source. The water accessed at these sites is to be used for agricultural purposes only.

Issue Date: December 11, 2015 Location: Fort St. John

Potable water must meet the Drinking Water
Protection Regulation to be deemed safe to drink and
fit for domestic purposes. The water tank loaders are
not treated in accordance with section 5(2) of the
Drinking Water Protection Regulation (BC Reg.
200/2003) and therefore do not meet the definition of
Potable water.
