Shock Trauma Air Rescue Society (STARS)

The Peace River Regional District Board presented STARS with a cheque fulfilling its commitment to provide \$170,000 annually for 2013, 2014, and 2015. Trauma Air Rescue Society (STARS) is a non-profit charitable organization that provides air ambulance service 24/7.

ALR Applications

The Regional Board forwarded the Bouffieux, Shaman, Friesen and Stewart applications to the Agricultural Land Commission.

Tumbler Ridge Global Geopark (TRGG)

The Peace River Regional District Board will send a letter to TRGG in support of its application for a Community Gaming Grant through the Province of BC to assist in efforts identified in the TRGG Master Plan.

Amended Development Application Procedures Bylaw

The Regional District Board directed that a draft amended Development Application Procedures Bylaw be brought forward for the Board's consideration. If adopted, the bylaw will require that applicants be provided with development permit signs, that signs are to be made of recyclable materials, and that applicants are to recycle the signs after use.

WPFA OCP Community Advisory Committee

Director Merlin Nichols was appointed to the West Peace Fringe Area Official Community Plan Community Advisory Committee.

Comptroller of Water Rights

The Peace River Regional District Board will make a submission to the Comptroller of Water Rights requesting that all recent and future correspondence and submissions regarding the Site C Water License Application Hearing and groundwater aquifer access be forwarded to the Regional District Office.

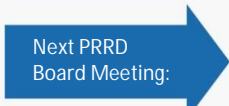
Section 149 – Failure to Stop for School Bus
